#### **PARTICULARS**

- 1. Pursuant to DepEd Order No. 10 s. 2025 on the Guidelines for the Implementation of the 2025 Department of Education Summer Programs; DepEd Memorandum No. 34 s. 2025 on Supplementary Guidelines on the Implementation of the Literacy Remediation Program, Regional Memorandum No. 598 s. 2025 on Regional Training of Trainers on the Literacy Remediation Program, this Office through the Curriculum Implementation Division shall conduct Division Literacy Remediation Program (LRP) Training for Volunteer Teachers at the Division Training Center on May 16-18, 2025, 8:00 A.M.— 5:00 P.M.
- 2. The training has the following objectives:
- a. to equip remediation teachers with practical and evidence-based strategies for addressing the specific literacy needs of Low Emerging Readers;
- b. to introduce and provide guidance on the utilization of appropriate instructional materials, assessment tools, and other resources that support the effective delivery of the LRP; and
- c. to promote a unified and standardized approach to the LRP implementation across the six identified elementary schools in DepEd City of San Fernando, ensuring equitable support for all Low Emerging Readers.
- 3. The training expenses which include materials and meals of participants, trainers and program management team (PMT) shall be charged to GAA 2025 Direct

Release (NLC Implementation) to be downloaded to SDO subject to the usual accounting and auditing procedures.

- All participants are advised to bring their own laptops or digital devices to participate in the hands-on sessions.
- Participants in the activity are entitled to service credits pursuant to DepEd Order No. 13 s. 2024 on the Revised Guidelines on Grant of Vacation Service Credits to Teachers.
- The participants of the division training are volunteer teachers of the identified 6. schools to implement the Literacy Remediation Program.
